## J&T EXPRESS SEA FREIGHT TERMS AND CONDITIONS

- This SEA Freight services shall only be applicable for all walk-in customers only.
- SEA Freight services shall be applicable for parcel delivering from West Malaysia to East Malaysia only.
- The sender may drop off the shipment at any J&T Drop Point, Courier Point or Premium Courier Point.
- The price above stated is including door to door delivery service.
- Price stated above is included shipping fees only. (All prices are excluded of 6% SST).
- Parcel standard: Actual weight and dimensional weight of the parcel shall not more than 70kg, one sides length no more than 150cm, and the sum of three sides no more than 300cm.
- J&T Malaysia shall not accept any sea freight shipment if it is classified as hazardous materials, dangerous goods, prohibited or restricted articles by the International Maritime Dangerous Goods (IMDG) Code or by any other regulation or laws which is imposed by the country of the Receiver. Notwithstanding the foregoing, the sender may refer to a list of general prohibited item at <https://www.jtexpress.my/prohibited.php>
- For SEA FREIGHT shipment, J&T Express Malaysia shall only be liable for the direct losses for damaged or lost items, but is limited to the following:
  - The actual amount of loss or damage based on the actual value of the contents as stated on purchase invoice of damaged or lost items or a maximum of RM100.00 for SEA Freight shipments, whichever is lower, for each consignment note with contents weighing 2KG and below;
  - The actual amount of loss or damages is based on the actual value of the content as stated on purchase invoice of damaged or lost items or a maximum of RM300.00 for SEA Freight shipments, whichever is lower, for each consignment note with contents weighing 2.01KG or above;
  - For any items with a value of RM1,000.00 or more, the sender is compulsory to purchase insurance for the specific items at the rate of 1% of the parcel actual value, the maximum insured amount will be RM10,000.00
  - Except as expressly stated in this Sea Freight Terms and Conditions, all other provisions as stated in J&T Express Malaysia Terms and Conditions for Shipping shall be applied mutatis mutandis to this Terms and Conditions of J&T Express Sea Freight.

This Terms and Condition is effective from 18th January 2021 and J&T Express Malaysia reserves the right to amend, change, or modify the contents of this Terms and Conditions at the Company's discretion from time to time without further notice.
